Toyota Boshoku America Inc. Uses iSecurity to Comply with International Regulatory Requirements

About the Company

Toyota Boshoku America Inc., headquartered in Erlanger Kentucky, is a leader in the automotive manufacturing industry with 15 key facilities in the United States. They have manufactured and supplied interior parts for over 17 years to automotive giants such as Toyota, GM, and Chrysler. Toyota Boshoku, a private company, needed to comply with J-SOX, the Japanese version of the U.S. Sarbanes-Oxley Act.

The Solution

Faced with having to comply with J-SOX due to a partial ownership of the company in Japan, Bob Bodinof (Business Analyst) and the IT staff selected iSecurity to provide the reporting and security necessary for their J-SOX audits. They found that iSecurity Audit was ideal for monitoring access to and use of sensitive data. iSecurity AP-Journal further enabled Bodinof and the J-SOX auditors to monitor sensitive data access down to the record level. The requirement for managing ODBC was handled by implementing iSecurity Firewall for monitoring and controlling remote access at the OS400 exit point level. The weekly and monthly reports generated by Audit, AP-Journal and Firewall were automated and sent directly to the J-SOX auditor for review.

Implementing iSecurity

With an undersized IT staff, Bodinof and the iSeries System Administrator implemented iSecurity Firewall, Audit, & AP-Journal solutions with minimal impact on production and during normal business hours and were up and running live within 4 weeks.

Audit & AP-Journal reinforced compliance by providing reports of the Audit journals (QAUDJRN) and changes in application files. “These two products are a couple of workhorses.
