Implementation/Rollout

Q - How was the integration of iSecurity with your existing infrastructure?
A - In a period of about one month, we achieved a good level of integration with the existing procedures and infrastructure.

Q - Who in your company uses iSecurity? A - For the time being, iSecurity is used by the IT department. We will be implementing new projects in the future and then the use of iSecurity will be extended.

Q - How is iSecurity being used?
A - We use iSecurity for producing automatic security reports and queries.

Q - Who provides professional services for iSecurity?

A - Raz-Lee's Support Manager provides professional services, including configuration, software engineering and implementation.

Soon we will be replacing our System i machines, and Raz-Lee's team will re-install the products for us, in the framework of their complete support. The repeated installation is expected to be quick, since we already finetuned the security rules, enabling us to simply restore the backed-up rules.

In addition, we are on the way to achieving regulation compliance. The first pre-auditing tests for the J-SOx compliance have been positive.
